Death Certificate Creation Process – Initializing, Reviewing, Approving and Obtaining the Completed Copies

We understand that death certificates are very important and that your family needs them as soon as possible. With that in mind, please know that the process to prepare these important documents can take up to, but is not limited to, **fifteen** working days. The process to prepare a death certificate follows a multi-step set pattern that includes:

- Meet with family and gather death certificate information.
- Enter this information into the state of Oregon's Electronic Death Registration System (EDRS). Social Security is notified by completing this step. Our funeral home does not contact social security directly.
- Print out and proof working copy of death certificate in office.
- Family to review and approve spelling and information on working copy of the death certificate either by fax, email or coming into the funeral home.
- Call doctor or primary care provider's office to check if the doctor will commit to sign the death certificate. If not, we find the appropriate physician or nurse practitioner. The process to find the correct medical professional is time-dependent based on their schedule, not our funeral home. Doctor's are sometimes out-of-town and are otherwise not available which can add an additional week for the doctor to sign the death certificate.
- Mail the death certificate to the doctor's office highlighted and readied for their signature.
- Doctor's office mails the signed document back to our funeral home..
- Proof the signed death certificate (re-send to doctor if incomplete).
- Courier delivers signed non-official death certificate to Lane county for processing.
- Once payment is received by the family for the death certificates, they will be completed by Lane County Vital Records and then be sent directly to the family. These documents can also be picked up at our funeral home.

Making A Change To A Death Certificate

Death certificates that are incorrect can be exchanged for revised death certificates assuming the family still has the original incorrect official copies.

A death certificate must be registered in the State of Oregon's electronic death certificate registration filing system before it can be amended. Registration takes several months. We monitor the progress of the death certificate registration by checking the system repeatedly until the change can be made on-line. This is the fastest way to make the changes requested to a death certificate.
